NVARC Constitutional Crisis!

If you weren't at the December meeting, the elections have been postponed. The election process was halted by Article II section 2 which reads as follows:

The officers of the Club shall be elected for a term of one year by ballot of the members present provided there be a quorum, at the annual meeting on the third Wednesday of April. A quorum shall be defined as 20 percent of the voting membership.

There are two choices for getting the elections back on track; wait until April or amend the constitution. Article VII of the constitution reads:

AMENDMENTS: This Constitution or the by-laws may only be amended by a two-thirds vote of the total membership. Proposals for amendments shall be submitted in writing at a regular meeting. Notification of all members shall be attempted by mail, and the proposal may not be voted on until the next regular meeting after the notification is made.

Russ, WR1Y, submitted a proposed amendment at the December meeting. This newsletter is formal notification of the proposal. **At the January 21st meeting, a vote will be held.** Now for Russ' pitch:

President's message

You will notice in this month's newsletter a proposed amendment to the constitution of the Nashoba Valley Amateur Radio Club. This change is proposed in order to make the annual election of officers more equitable and manageable. The constitution currently sets the elections on the third Wednesday of April, and oversight during the initial formation of the club. The suggested changes will allow more candidates to be considered, a period of time to evaluate the candidates and finally, a break-in period before the newly elected persons take office.

We have enclosed a proxy form in this month's newsletter for members that may not be able to attend the **January 21st** meeting. It requires a two-thirds majority of the members in good standing to change the constitution. The proxy form will allow you to vote for or against the proposed amendment without being physically present. If you question the rationale, please give me a call so that I'll get a shot at convincing you of the benefits of the new election system.

The following is a transcription of the amendment sheet passed out by Russ at the December meeting:

Moved that the constitution of the Nashoba Valley Amateur Radio Club be amended as follows:

A nomination committee shall be appointed at the monthly meeting in November of each year. This committee shall present a slate of candidates to the collective membership at the December monthly meeting. Nominations will be accepted from the floor at this time. Election of officers shall be held at the January monthly meeting. The newly elected officers shall attend all board meetings and officer functions in concert with the officers of the previous year. At the April monthly meeting the newly elected officers shall assume the full responsibilities of their respective positions. During the three

month period of duality, the decisions of the officers from the previous year shall be binding. The purpose of this amendment is to create a smooth transition between consecutive administrations.

WB1GOF - The Saga Continues

EMERGENCY AUTODIAL NUMBERS CHANGE ON WB1GOF REPEATER

Effective today's date changes have been made to the Emergency Autodial numbers accessible through the WB1GOF repeater.

For review, to access the Emergency Autodial features on the repeater, you should first ID yourself and announce who you are calling. Then using the table below, punch in these numbers on your DTMF pad on your radio. All number are preceded by the asterisk key. The repeater will speak the autodial number you have punched in. After the voice is finished, click your mike key once to acknowledge.

You will then hear a series of tones which are masking the DTMF tones being dialed, in a couple of seconds you will hear the phone ringing. When the person answers, announce that you are a two-way radio operator making a report, are you ready to copy? (It is not necessary that you provide your callsign or other personal information unless requested.) Make your report and wait for them to acknowledge.

After the information has been taken and they have disconnected, you must "close" the autopatch with the # (pound symbol) on your keypad. The repeater will announce the call is complete. Once again at that time you should ID yourself.

*919 can be used for any NH emergency call as well as any Massachusetts highway call. SP Concord would like to get ONLY calls in their jurisdiction... so if you are not sure, use the *919. Please be prepared for a long delay for the ringing to start, we are using the 800 number.

Remember to speak clearly and make sure you are "good" into the repeater... S7 or better!

Ham Class Report Card -- Test Results

On December 9th NVARC held its first VE session. For those interested, in the statistics, here they are:

Total Candidates: 16

Total exams administered (code, written and re-takes): 53

Total newly licensed: 6

- Technician with code: 4
- Technician with no code: 1
- Novice: 1

Total passing one or more elements but not qualifying for a license at this exam: 6

Success rate: (licenses/candidates) = 37.5%

Breakdown of candidates by age:

18 and over

Licensed: 6

Partial success: 2

Under 18

Licensed: 0

Partial success: 4

We note that if candidates were grouped as 13 OMs and 3 YLs, the YLs had a success rate of 2/3 or 66.6% (qualified for a license,) whereas the OMs had a 4/13 or 30.8% success rate. I refuse to comment further. HI!

Also, as a matter of record, we had 6 families taking their exams.

The ARRL/VEC has notified me that the FCC forms 610 were submitted to the FCC on December 22nd and that there were not any problems with either the paperwork or the test session. Congratulations to our VE team.

Nashoba Valley Training Net

Rules for Net Discipline

A good net is a disciplined net, and discipline is something that must be enforced by the net control station (NCS) and observed by all net stations. To the extent it is not, the efficiency of the net suffers. Here are some hints to help you help the NCS observe proper circuit discipline.

1) Zero beat your signal with that of the NCS. The net frequency is where the NCS is. Your station should be equipped so you can zero beat NCS without putting a signal on the air. Don't make it necessary for him or her to tell you that you are too low (QNL) or too high (QNH). Make sure you are right on before you QNI.

2) Report in on time. Be ready to QNI at the appointed time. A net cannot operate smoothly if net stations report in three, five or 10 minutes late.

3) List your traffic properly, if you have any. The proper destination first, number of messages second. A prerequisite to this rule is to be familiar with the check-in procedure of the net.

4) Never transmit without the NCS's permission, in a directed net, except in an emergency or when returning from a side frequency assignment. In such cases, make your transmissions ultra-brief.

5) Call the NCS only if you must. This is in line with the above, but occasionally you have a situation that requires you to notify the NCS. Avoid doing this frivolously. If you must be excused, disregard the reason: just ask to be excused. Never call the NCS to advise him he is doing something wrong.

6) On the net frequency, transmit only to the NCS unless he instructs you otherwise. Unauthorized side comments with or to another station are strictly out of order.

7) Answer promptly when the NCS calls you. Stay alert. Don't fall asleep and be caught napping. In a busy net, the NCS may call you only once, and if you don't respond promptly he may assume you have left the net and cross you off the list.

8) Don't leave the net until you are excused by the NCS, either specifically or by a general QNF ("the net is free"). If you must leave the net temporarily, be sure to get the net control's permission first, then report back in as soon as you can.

9) Answer the NCS's questions or inquiries briefly. Avoid long explanations; just answer the question. If he asks if you will volunteer for a liaison job, just say yes (c) or no (n). If the latter, don't explain the reason;.

10) Know your procedure. Nothing is more frustrating for an NCS than to have to explain procedure to someone who should be familiar with it. The more thoroughly familiar you are with the procedure the more valuable you are as a net station.

SO, HOW COPY?

First, special congratulations to the people who passed their exams at the NVARC test session!

And for those who didn't make it -- don't be discouraged -- review the material and try again. It's worth the effort!

So how about the amendment? Two things jump out at me:

1) The new amendment lengthens the commitment of a candidate from 12 months to 15 months.

2) Officers newly elected are powerless even though they represent the most recent polling of the membership.

I have to respectfully disagree with our president and provide a counterpoint to the front page:

It seems to me that we are proposing changes to the constitution to cover for having jumped the gun on the election process. Why not have elections in April?

The new amendment is more specific about the election process, but there is nothing in the old rules that prevents using the same process at the appropriate time.

The new amendment mandates a three-month overlap of terms "to create a smooth transition between consecutive administrations." But why? We've never had a change of officers, so it's addressing a hypothetical situation. Is it likely that outgoing officers won't be willing to give incoming officers advice unless it's required? I can't endorse requiring people to spend three months attending meetings when they have no authority.

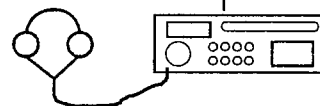
