## A Note to the New Hams

And not-so-new Hams. As of March 1 1994, a new FCC form 610 has been in use. No other form will or can be used. All the test sessions should have the new forms by now...Unlike the past where the FCC would accept the last few versions they will not this time. This has to do with their systems/computer upgrades. The new form is laid out to coincide with the data entry screens. They are working toward an FCC BBS system that will allow electronic filing. The FCC envisons a 2-3 day FCC processing time once this is accomplished (This is still a year or two off--ed).

Another change is that each candidate must provide a copy of each CSCE submitted for the VE's to attach to the form 610. You don't want to give up the originals, so you must bring a copy Stan Pozerski KD1LE
