German Cosmonaut Thomas Reiter, DF4TR, will join the Russian space station MIR, and operate signing DP0MIR, during the European Space Agency's "EUROMIR 95" mission beginning September 2, 1995.

Reiter will use the 2-meter FM rig aboard MIR during the 135 days planned for his flight. Primary frequencies to be used (preferably in split mode) are 145.800, 145.550, and perhaps 145.200 MHz.

# **Sun Spots**

ARLX046 Sunspot hints new cycle

Astronomers at the California Institute of Technology say they have identified the first new sunspot in the next sunspot cycle. Scientists at Caltech's Big Bear Solar Observatory in Big Bear City, California, photographed the spot on August 12.

"This makes us happy," said Hal Zirin, professor of astrophysics at Caltech and director of the Big Bear facility. "The sun is a lot more interesting to study when things are going on." Early in the 11-year sunspot cycle, sunspots appear rarely and at relatively high solar latitudes around 30 to 35 degrees, then increase in frequency and appear at lower latitudes until they reach sunspot maximum, Caltech said. After this peak in activity, the number of sunspots slowly declines, and they appear ever closer to the sun's equator until they reach a relatively quiet phase called sunspot minimum.

The sun has been in a quiet period through much of 1994 and this year, with a few spots showing up near the equator. The new sunspot found on August 12 appeared at a solar latitude of 21 degrees, and its magnetic polarity is opposite to that seen over the last decade, a key to identifying it as "the manifestation" of the start of a new cycle, Caltech said.

Scientists at Caltech said they expected an early beginning to Cycle 23, but not this early. "Sunspots in the new cycle should rapidly become more common and reach a high level of activity in 1998 or 1999," Caltech said.

Citing an "outpouring of love, selfless effort, and resources, "Nickles said the community is "indebted to those volunteers who created (a) silver lining" to the dark cloud of the tragedy.

"Specifically," Nickles said, "Amateur Radio operators provided an essential service to rescue operations. Within minutes of the attack, operators were on the scene providing an emergency communication network that allowed for the organization of supplies as well as firemen, policemen, and rescue crews from countless communities. "Their contribution of 360 hours of service was made possible by donations from electronics companies such as the Oklahoma Community (Communications) Center," Nickles said.

Sen. Nickles's remarks were published in the August 11, 1995, Congressional Record, thanks in part to the efforts of ARRL Oklahoma Public Information Coordinator Thomas M. Webb, WA9AFM. An article by Webb about Amateur Radio's role in this matter appears in September QST. Also helping, in Washington, was George Stephens, WB3DAC, who is the staff of the Senate Republican Policy Committee, of which Sen. Nickles is chairman. (Stephens also is president of the Capital Hill Amateur Radio Society, W3USS.)

### **FCC Plans**

SB QST ARL ARLB080 ARLB080 FCC plan considers RFI

The FCC is considering "privatizing" the resolution of radio frequency interference to consumer electronics devices. Under the plan, private repair shops would be used to fix problems "in the field."

FCC representatives spelled out the Commission's concept at a meeting in Tampa, saying "Since it is not feasible for the Commission to attempt to resolve these complaints" (the most of which come from Citizens Band operation), "it is our policy not to investigate interference to home electronic equipment. Likewise, we do not offer any protection from interference."

Over past several years, the FCC has been "unofficially" out of the "retail" RFI business, and parties who contact the FCC about an interference problem are asked to work together toward a solution.

Depending on what the local repair shop found, either the shop would fix the equipment or, in the case of a violation of FCC rules, the service shop would refer the case back to the FCC for possible FCC action. The question of who would pay was not addressed.

The ARRL, which had responded to an FCC request for input before the meeting, was represented at the meeting by several local volunteer officials, in consultation with ARRL Laboratory Supervisor Ed Hare, KA1CV.

### **Monserrat**

From ARRL Headquarters Newington CT August 30, 1995 To all radio amateurs SB SPCL ARL ARLX048 ARLX048 Accident on Montserrat Bobby Martin, VP2MO, has been seriously injured, and his wife, "Mae" Martin, VP2MN, has died in an accident on the island of Montserrat.

The two had temporarily relocated to Antigua following volcanic activity that began on the island in late July. They were back on Montserrat where the accident, involving an automobile and a British military vehicle, took place on Sunday, August 27.

Bobby Martin has been hospitalized at Hoberton Hospital on Antigua and, although seriously injured, is expected to recover, according to those who have spoken to attending physicians there.

Most residents south of Montserrat's volcano (Soufriere, 3000 feet high) have been relocated to the north side of the tiny island, farther away from danger. The volcano continues to "rumble and spew ash," according to Perry Brittain, VP2MR/W5STI.

Bobby Martin has been well known for many years as one of the Caribbean's most active amateurs. In 1990 he received a British knighthood for his work following Hurricane Hugo, which devastated Montserrat in September 1989.

Stories about Montserrat appeared in QST for March 1990 and February 1991.

A funeral for Mae Martin was expected to be held sometime this week, on Montserrat.

SRI LANKA, 4S. HB9BRM, will be active September 14 to October 3 as 4S/HB9BRM on 80 through 15 meters. QSL to home call.

NEPAL, 9N. Roger, G3SXW, should be active as either 9N1SXW or 9N1/G3SXW September 12 to 21. This will be an all band CW only effort. Try 1827, 3507, 7007, 10107, 14023, 18073, 21023, 24893 and 28023 KHz, QSX up 2 to 5 KHz. QSL direct to G3SXW or via the bureau.

ZAIRE, 9Q. Joe, G3MRC, is on as 9Q5MRC. He has been on 18081 KHz around 1845z. Joe also has plans to operate from Bu-

rundi, 9U. 9Q5TR can sometimes be found on the 14226 DX Net at 2230z.

TURKS AND CAICOS ISLANDS, VP5. Nob, JA7AYE, is signing VP5/JA7AYE. He has been heard on 14010 and 14195 KHz throughout the day. Also check 7016 KHz at around 0315z. QSL via JA7ZF.

SAINT PIERRE AND MIQUELON ISLANDS, FP. K9GS, ND9O, N9AU and W9OP will be active October 25 to 31. They will sign TO5M during the CQ WW SSB Contest. Outside of contest hours they will sign FP/home calls. QSL to K9GS for all calls via CBA.

MADAGASCAR, 5R. JF1MGI has rescheduled his DXpedition. It is now to take place during October and November.

CAYMAN ISLANDS, ZF8. Tosy, JA6VZB, and Seiji, JH6RTO, will be on from Little Cayman signing ZF2TY/8 and ZF2SF/8, respectively, September 24 to 28. CW, SSB, RTTY and SSTV is planned for this all band effort. On September 28 and 29 they may be active from Grand Cayman. QSL ZF2TY via JA6BSM and ZF2SF via JH6RTO. Buzz, N5FTR, will be active on 40, 20, 17, 15 and 10 meter SSB September 3 to 9. QSL via his CBA or the W5 bureau.

SAINT MAARTEN, PJ7. Mike, K6URI, will be on as PJ7/K6URI September 9 to 23. Listen for his CW and SSB on 40, 20 and 15 meters. QSL via K6URI.

ANTIGUA, V2. Stephen, WF2S, will be active as V26Z September 17 to 30 on CW and RTTY. He will be in the CQ WW RTTY Contest. QSL via WF2S. Bob, W2KKZ, will be signing V26Y September 24 to 30, mostly on CW. QSL via W2KKZ. Some Frankford Radio Club members will activate V26B in the CQ WW SSB Contest October 28 and 29. Outside contest hours, listen for N3BNA as V26A, WT3Q as V26B, N3ADL as V26DX, AB2E as V26E, KA2AEV as V26R, K3MQH as V26T, WA2UDT as V26U, KF3P and WB2P. QSL via home calls except V26A via WB3DNA.

# **Reciprocal Agreements**

From ARRL Headquarters Newington CT September 8, 1995 To all radio amateurs ARLB085 3rd-party, reciprocal news

The Federal Communications Commission has added three countries to the list of those with which the United States has an Amateur Radio reciprocal operating arrangement.

They are Bosnia-Herzegovina, Croatia, and the Former Yugoslav Republic of Macedonia.

The FCC also has added the Republic of the Marshall Islands to the list of countries with which the US has a third-party traffic agreement. A visitor to the US from a "reciprocal country" may obtain a permit valid for one year by sending a completed FCC Form 610-A application and a copy of his license to the FCC's Gettysburg, Pennsylvania office.

Complete lists of US third-party traffic countries and reciprocal operating arrangement countries are available by sending an SASE to ARRL Headquarters, or electronically through the sources listed in "How to Contact the ARRL" in each QST.
